Suggested Roles for LTRAS Meeting Participants -

LTRAS Director and Management Group:

- Plan process.
- Define overall purpose and parameters for meeting.
- Encourage full and thoughtful involvement.
- Participate fully in retreat.
- Make final decisions as needed.
- Ensure follow-up on agreed upon actions.

Meeting participants:

- Participate fully.
- Focus on the “content.”
- Operate as “peers” in planning the future.
- Share responsibility for success of the meeting and LTRAS.
- Support each other and the process.
- Maintain meeting agreement.

Facilitator:

- Focus on the “process” – suggest and guide.
- Stay neutral and out of the content.
- Encourage full involvement.
- Help group stay on task and on time.
- Protect individuals and ideas from attack.

Recorder:

- Capture key ideas on chart paper.
- Honor the words of the speaker – not edit.
- Support the group and the process.

Meeting Agreement –“Ground Rules” for meeting:

- Honor our time commitments.
- Listen actively – “One person speak at a time.”
- Encourage full and equal involvement – give everyone a voice.
- Focus comments on the topic at hand.
- Keep an open mind, “Give all ideas and input full consideration.”
